Dear Mr. Waite:

My law office serves as counsel to the Town of Cicero. The current approved solid municipal waste hauling contract serving the Town expires 1/31/2016, but also contains extension language allowing the agreement to be extended in ten (10) month increments upon the written approval of both parties.

The Town of Cicero Board approved an extension of the current agreement under the same terms and conditions contained therein for an additional ten (10) month period by resolution. The same resolution also authorized the Supervisor to execute this extension letter. I am writing to obtain your signature on this letter evidencing your consent to extend the contract as well.

Execution of this letter below indicates the agreement and understanding of the parties to extend the terms and conditions of the current contract for an additional nine (9) month period (excludes December as per agreement) until 1/31/17. Kindly execute the two (2) original letters enclosed herewith and forward them to the Town of Cicero Supervisor's office for execution by the Town. Once the Town has executed both original documents, I ask the Supervisor to mail you back one fully executed original to retain for your records.
